New Language Program (15 points)

- 15 points: Proposal outlines the implementation of a new program not previously offered within the school division.
- 10 points: Proposal expands an existing language program to a new school or location.
- 3 points: proposal expands an existing language program to new grade levels in the same school or location.
- 0 points: Proposal suggests adding additional sections of the same language at the same levels and location.

Teacher Qualifications and Experience (15 points)

- 15 points: Highly qualified language instructors with significant experience in teaching critical languages.
- 10 points: Qualified instructors with relevant experience in language education.
- 5 points: Instructors with some relevant experience or expertise.
- 0 points: Instructors lacking sufficient qualifications or experience.

Program Integration (10 points)

- 10 points: Detailed plan for integrating the program into the broader curriculum and educational goals of the school division.
- 5 points: Some integration strategies outlined.
- 0 points: Little to no consideration for program integration.

Innovation and Program Enhancement (10 points)
